Subject: Dis-engagement/Termination of services of Ms. Rizwana Fayaz engaged as Special Educator on contractual basis under PM SHRI Scheme.

Whereas, Ms. Rizwana Fayaz D/o Fayaz Ahmad Kaboo was engaged as Special Educator *vide* Order No.: 67 - Chirag of 2024 dated: 07-03-2024 under PM - Shri Scheme and posted in GHS Chogal, Handwara District Kupwara.

Whereas, Chief Education Officer, Kupwara *vide* letter no. CEO/KUP/Samagra/IE/9461-62 dated 04-07-2024 and CEO/Kup/Samagra/IE/9739-40 dated 16-07-2024 informed this Directorate that the said Special Educator has remained absent from her duties since 22-05-2024, without approved leave.

Whereas, as per Chief Education Officer, Kupwara's communications, Headmaster, Govt. High School Chogal has issued an explanation against the Special Educator *vide* letter no.: GHSC/2024/34 dated 03-06-2024, followed by a final reminder/explanation *vide* letter no.: 380-GHS/CHG dated 15-07-2024 for un-authorized absence from duties.

Whereas, despite explanation and reminder by Headmaster, Govt. High School Chogal, Ms. Fayaz failed to respond to any of these communications and has been absent from duties without the approval of any competent authority and despite repeated communications has failed to respond and resume duty.


Whereas, a show cause notice was issued *vide* No: Edu/PD/SmS/PM Shri/9647-52/2024-25 dated: 13-09-2024, providing an opportunity to Rizwana Fayaz to explain her position before this Directorate within Seven days from the date of issuance of this notice.

Whereas, Ms. Rizwan Fayaz in response to the said show cause notice has replied that her husband has recently secured employment in Pune, Maharashtra, due to this sudden and significant development, she had to relocate to Pune to join her family. This move to Pune has made it difficult for her to continue her services at GHS Chogal.

Whereas, in light of the above circumstances and in accordance with the point no 5 of Order No.: 67 - Chirag of 2024 dated 07-03-2024 which read as under:

"The performance of the selected candidates in the district shall be assessed after every three months and the non- performing candidates shall be terminated without any further notice",

Therefore, the services of Ms. Rizwana Fayaz D/o Fayaz Ahmad Kaboo, R/o Umer Abad Sopore engaged as Special Educator under PM - Shri Scheme are hereby terminated effective 22-05-2024.
